## Old Admin gets public meeting


The State Center Community College District Board of Trustees will hold a public meeting to discuss the fate of the Old Administration Building Sept. 29.

The board has set Oct. 13 as the date it will decide whether to demolish the building constructed in 1916.

The latest estimate to restore the old building is \$8.4 million. A number of public and private funding ideas have been considered, but so far none have become available.

The board has considered demolishing the building since 1972 because of its failure to meet state earthquake standards.

Board members said they want to hear concrete ways to come up with the money at the meeting.

### Old Admin deadline near

The State Center Community College District ignored a chance last year to apply for state funds that could have helped save Fresno City College's Old Administration Building, according to state officials.

The funds, that amounted to a maximum of \$300,000, were available through the Parks, Recreation and Historic Bond Act of 1984.

At the urging of Fresno Assemblyman Jim Costa, a staff member of the state Historic Preservation Office visited Fresno last October and discussed the funding option with representatives of the SCCD and the city of Fresno.

Though the SCCCD Board of Trustees has expressed a desire to save the building they reportedly turned down the chance to apply for the bond money because it would not come close to the \$8.4 million required to restore the aging building.

The district has maintained that it has been unable to raise funds to save the 71 year-old structure.

The SCCCD has set an Oct.

1 fundraising deadline and plans to demolish the landmark if funds to save it are not available then.

Last spring, Costa proposed making the building exempt from state earthquake standards for the next five years. The board cited the high cost of the earthquake regulations as a major stumbling block in saving the building.

However, according to Costa's aide Mark Scozzari, "there is going to have to be some community involvement" in the effort to save the building.

## **Enrollment Increases**

Campus officials reported that City College enrollment is up from last semester, because of a promotional and advertising campaign aimed at local high school students.

Pamphlets and radio advertising, along with an oncampus school relation staff helped the campaign recruit new students, Dave Jimenez, the college's public information officer, said. The Admissions Office expects the school's enrollment to exceed 16,000 when the late registra-

tion tallies are added up. Less than 15,000 attended FCC last fall.

building's arched hallway.

The fact that FCC competes with both the universities and business and vocational training schools played a large part in the plan to increase advertising within the community, said Jimenez. The business of attracting new students is something the administration has been working to expand.

Jiminez said the college is trying to provide an alternative close to home, where students can get both an education and some of the same opportunities that universities and other schools provide.

"We have programs here that we think will benefit students," he said.

While admitting that parking on campus will still cause the students and staff problems, he said that overcrowding will not be a factor in the classroom, due to a sufficient number of teachers to cover most classes.

# Sosa dispute heats up again

An attorney for the State Center Community College District is investigating the alleged verbal abuse of a student by Fresno City College instructor Dr. Luis Sosa.

The incident, which occurred in Sosa's "Drug Use and Abuse" class in late August, gained media attention Sept. 1 when Student Trustee Brian Lampson released a portion of a tape of the instructor's remarks at a press conference inside the Board of Trustees gallery.

A statement by Lampson and the tape were aired on local television newscasts later that day.

On the same day, Sosa announced he was filing a lawsuit in federal court, charging the SCCCD with racial discrimination and harassment as reasons he has not been appointed to chair the school's sociology department.

Sosa called the charges of verbal abuse "ridiculous," and said his comments

"were taken out of context."

College spokesman Dave Jimenez said the investigation was turned over to the district's attorney, Joe Zampi, after college administrators interviewed the students involved.

Zampi, contacted in his San Diego office last Friday, said he hadn't had the opportunity to review the case, but acknowledged that the information had been given to his office.

"At this point, this whole thing may be nothing," Zampi said.

College President Earnest Leach declined to comment on the case, saying it would be unethical for him to divulge any comments made to him by students.

Lampson claims he was acting in his role as student trustee when he went to the press with a statement and the tape. He said a student recognized him in the college cafeteria, gave him the tape and told him to "do something about it."

The student trustee is an elective officer of the college who serves as a liason between the Associated Student Body and the Board of Trustees.

"I believe this student was wronged, and I want something done about it," Lampson said.

A transcript of the tape shows Sosa telling a student that "anything she had to say was horrible," and "you always have ignorant, stupid students making all kinds of

## Vending Delayed; course offered

Dr. Ernest Leach, Fresno City College's new president, should be commended for the way he is handling the controversy over installing condom vending machines in the campuses restrooms.

Last semester the Associated Student Body gained national attention after a resolution was passed to provide condom machines in the bathrooms for FCC students. The problem was that the ASB failed to propose any education program about the proper use of condoms or about giving students instruction of how not to be exposed to sexually transmitted diseases. In effect, the ASB preferred to just throw condoms at students in the hopes that it would stop the spread of AIDS, the fatal disease that attacks the body's immune system and is transmitted by intimate sexual contact.

Leach apparently understands that condoms without education will not stop the spread of the disease, and is waiting for a State Center Community College District commission to develop a district-wide policy on AIDS before making any commitment about what route the college will take on this important issue.

In the meantime, a 12-week course will be offered on campus in September on the medical and social factors of Acquired Immune Deficiency system, the first course of its kind at FCC.

Students should be thankful that the school has an administration that understands the deeper issues involved in the AIDS crisis, instead of quietly going along with the shortsighted ASB proposal of condom dispensing.

While it is true that condoms can help prevent the spread of AIDS, they are not 100 percent effective. The United States Department of Health and Human Services, in a recent report, showed that four out of 1,000 condoms fail even when used properly. Why take the chance of relying on condoms as the only measure of safeguarding against sexually transmitted diseases? Why not focus on education as well?

Condom manufacturers undoubtably question these statistics but, are they interested in stopping the spread of diseases or are they more concerned with the huge profits that can be made from condom dispensers?

Stopping the spread of AIDS and other sexually transmitted diseases can only happen after people are given a thorough education on "safe sex" behavior. FCC should provide both counseling services and educational programs to give students an opportunity to find out the risks that sexual activity comes with, and ways to avoid these risks.

Then, and only then, the college can dispense condoms and offer birth control devices to students.

Well-meaning but misguided decisions about how to stop the spread of AIDS will only cover up the problem instead of preventing.

CONSTITUTION ON TRIAL - Chock one up for Jello Biafra.

Biafra, the former lead singer for the punk rock band the Dead Kennedys and notorious political hellraiser, was on trial in Los Angeles earlier this month for obscenity and distributing offensive materials to a minor.

The charges stem from his band's release of the album "Frankenchrist" in 1985. The album contained a reproduction of the poster "Penis Landscapes," by award-winning Swiss painter H.R. Giger. The poster shows 10 sets of male and female reproductive organs copulating, and had been widely seen in art circles before the band released the album.

What happened was a mother became outraged after her 11 year-old daughter bought the album for her 10 year-old brother and they found "Penis Landscapes" inside.

She sued both Biafra and his record company, Alternative Tentacles, for obscenity.

The interesting thing about this case, aside from its constitutional implications, is that it involves people who believe that reproductive organs are obscene.

Parents let their kids watch and participate in the unnaturl acts of violence and aggression, encouraging them to emulate the likes of Rambo and Ollie North, but draw the line when it comes to talking about the natural act of copulation.

Parents aren't the only ones to blame, though. I checked the nearest dictionary while I was writing this column (New Concise Webster's Dictionary, Specially Designed for Home, Office and School, Clear Typer 1984) and the words "penis" and "vagina" weren't even listed. horrible remarks to me, like this one."

Sosa said his dialogue with the student was an example of how some authority figures can dominate people and reduce their selfesteem. He said other menbers in the class admitted afterwards the student was not insulted.

"The student herself agreed," said Sosa. "She said in front of class (a week later) that she was not abused."

Lampson said the student was upset over the issue and was afraid to come forward herself. He also said he could not give The Rampage a copy of the tape because he gave it to the Board of Trustees during executive session Sept. 1.

However, Harry Hiraoka, the board's secretary, said the group hadn't received a tape or any formal charges Sept. 1 and that he hadn't heard either the tape or Lampson's press statement.

The girl who gave the tape to Lampson and the girl who was allegedly insulted have since dropped Sosa's course.

Lampson went to the ASB the morning before the press conference to seek an endorsement for his statement.

The ASB, according to President Richard Montanez, declined, telling Lampson his charges "had no substance." The ASB also released an official distancing statement themselves from the student trustee because they had not been notified of any grievances and didn't have an opportunity to investigate the claims that Sosa insulted a student.

"We didn't want to end up crying wolf," Robert Hendricks, ASB legislative vice president, said. "It would be irresponsible."

The main reason the ASB decided not to support Lampson was because he told the group he had not talked to the student about going to the press.

"When asked point blank 'Did you talk to the girl?' Lampson said he did not," Montanez explained.

Lampson told The Rampage a day later that he talk-

ed to the student and she told him to go ahead with the press conference.

Montanez also said Lampson claimed to have the autority to release his statement from SCCCD Chancellor Bill Stewart and other top-level administration officials, including college spokesman Dave Jimenez.

Stewart said he knew of the tape and its contents, but did not confer with Lampson about his plans.

"Brian Lampson was acting on his own," said Stewart. "He has a right to be at the press conference just as much as anybody

The chancellor said, to his knowledge, Sosa was the only one holding a press conference that day.

Jimenez said he heard the tape before it was given to the media, but did not tell college administrators or the president about it's content.

When asked if it's Jimenez's responsibility to inform him of such matters, Leach said, "If he's informed about it."



#### Psychological services help troubled students

Each semester, some 300 students make use of the services of the Psychological Services Department located in the Student Services Building.

"A good sixty-percent of these students are referred to us by instructors or counselors," said Jeff Baird, one of the staff. "Although many just drop in." The peak period occurs during mid-term and finals.

When asked what are the major concerns of the student in the '80s - like sexuality, suicide, AIDS, nuclear war — he would only say that the problems are wide-ranging and varied, running the gamut from pre-test jitters to family/spouse difficulties.

"We provide short-term counseling; eight individualized sessions per semester. That's usually enough to do some good. If further help is needed, they are referred elsewhere," he explained.

The referral network includes agencies such as the Adult Intervention Center, ADAPT (Aid to Divorce Adjustment Problems of Today), Battered Women, HET (Help in Emotional Trouble), Planned Parenthood and Counseling for rape.

The Service works closely with the Nursing Department and the campus police in crisis intervention for oncampus situations.

The 1987 queen will receive a \$500 scholarship from Gottschalk's Department store. The two runners-up will get \$300 and \$200 scholarships.

When the Cal Bowl was established in 1981, queen candidates came from area high schools. Later officials decided that older candidates would provide more flexibility for the many social functions which preceed the Cal Bowl.

Melissa Matheny was last year's queen and Julie Lagrand was the first queen from FCC in 1985.


