**Bills Gain Ground** 

## Help for Admin Building

With the September fundraising deadline to save Fresno City College's Old Administration Building approaching, two bills designed to pardon the landmark from proposed demolition recently cleared legislative hurdles.

A bill that would exempt the building from state earthquake standards got a 58-11 stamp of approval on Monday by the state assembly.

This bill, which now goes to the state senate, gives the State Center Community College District approximately five years to decide the fate of the aging structure

Another bill, that sets aside \$200,000 in the 1987-88 state budget for the restoration of the FCC landmark, gained both assembly and senate approval, and now awaits approval by Governor Deukmejian.

The bills have been sponsored in the state legislature by Assemblyman Jim Costa and Senator Rose Ann Vuich.

According to a report pre-

According to a report presented at Tuesday's SCCCD board of trustees meeting by structural engineer Rick Ransom, restoration of the building will cost "a minimum of \$8.4 million." The report was prepared by the structural engineering firm of William A. Brooks.

The district has maintained that it does not have sufficient funds to restore the 71-year-old building.

The Fresno Heritage Foundation, which has attempted to fund the restoration of the building through private channels, is planning a fundraising event on June 7 in the courtyard of the structure.

According to Bruce Morris of the Heritage Center, "We have not received any major commitment for funding yet."

In an agreement with the state, the district will assume ownership of the building in October. The building is now state property and is the temporary site of the California Agricultural Museum.

# Toomasian Era Comes to an End -- Coach Calls it Quits

After 14 seasons Fresno City College basketball coach John Toomasian is stepping down.

Toomasian announced his resignation at a news conference Wednesday.

"Let's just say I'm tired," said Toomasian. "At 62 I don't need to be involved with 35 nerve jamming contests every year. If I was young enough to handle it I'd probably consider it."

This is Toomasian's second resignation as basketball coach since he began his career at FCC in 1965. Toomasian stepped down in 1975 after 10 years as FCC's

basketball coach. He returned in 1983 when the men's basketball program was nearly eliminated following the resignation of

Gary Hulst.

Toomssian's last three seasons have been particularly outstanding ones for FCC athletics. In 1985 Toomssian led the Rams to the state playoffs. In 1986 and 1987 the Rams claimed the CVC title outright and posted records of 23-11 and 24-9.

Toomasian's resignation comes at a point in his career where he is only 10 wins away from breaking the record of former Rams basketball coach Joe Kelly who is the all-time leader in wins at FCC with a record of 275-102.

Toomasian plans to remain at FCC in his current position as a history instructor.

## **ASB Officers -- What They Do**

These are the major responsibilities of each of the major offices as set forth by the ASB Constitution and By-Laws. In some cases there are other minor duties which were not listed here.

Chair the Executive Board and ASB Cabinet meetings; Countersign requests for payment when the Executive VP is unavailable; Accept speaking engagements; Attend Faculty Senate, Board of Trustee, FCC President's Cabinet, and Budget Committee meetings; Appoint standing committee members and Faculty Senate representatives by the fourth Senate meeting; Attend as many ASB functions and Senate meetings as possible.

Executive Vice-President:

Handle financial matters in conjunction with Business Office; Countersign all ASB requests for payment; Present monthly financial statement to Senate; Present to outgoing Senate in spring a financial guideline for the incoming Senate; Chair the **Budget Committee meetings** and help with the budget; Advise all committees on budget matters; Inventory ASB assets and report to the Senate four weeks before the last meeting; Vote at ASB Cabinet meetings and Budget Committee meetings; Attend and vote at Senate meetings.

Legislative VP Vice-President:

Chair Senate meetings; Appoint President Pro-Tempore of the Senate, Parliamentarian, and Ad Hoc or special committees; Attend FCC President's Cabinet meetings and as many Faculty Senate and Board of Trustee meetings as possible; Attend and vote on Executive Board and Budget Committee.

Tempore:

### **Distinguished Maestro Leads FCC Orchestra**

Alex Molnar, director of the Fresno City College Community Orchestra is a dedicated human being as well as a musician.

He was born in Yugoslavia, but moved to Salzsburg, Austria at the end of World War II. From there he and his family moved to Fresno in 1955.

Since he knew only German and Serbo-Croatian, he enrolled at Fresno State in 1957 to learn English. Because of the language barrier, "it was very, very difficult." There were times when he felt like giving up, but with persistence he survived. "The sun shines always at the end of the tunnel," he said.

In the fall of the same year, he enrolled in the Music Department to learn English music nomenclature. "With all my degrees, I had to be a student like everybody else," he said.

"In music one is always busy, never out of contact," he remarked. He started teaching piano at FCC in 1966, and also taught other fundamentals of music, music appreciation and music history. He then established the piano department before retiring in 1984.

Also in 1966, he founded the Fresno City College-Community Orchestra for "purely idealistic reasons." It is designed for students and people in the community who want to play classical music. "It is for those people in the community who don't have the time to play in the Philharmonic." The orchestra began with four people,

three students and one faculty member, which has now grown to around 55 performers.

"It is very difficult at a two-year institution to find people, especially students," he said. By the time the students enroll into the orchestra they graduate and go on to other programs. More students have since enrolled in the program, including local high school students, but there is a great need for musicians.

For the future of the orchestra he would like to see a little more publicity. He has concern that the public is unaware of all the activities on campus.

"I am sick and tired, after 20 years, of always fighting for a little publicity." There were times when he would

have to beg for a small advertisement in the Fresno Bee. "Then it would be so small that no one notices," he added.

"Students should be acknowledged," he said. "When they give their time to perform, it is important to

them that there is a reward because performing is difficult."

In his opinion, all the music is not publicized as it should be, a showcase for the College. He wishes there wasn't any discrimination between school functions. He feels there is too much emphasis on sports. "All functions bring the public and other students to the college," he said. "The college is for everybody."

To his knowledge, FCC has one of the best musical staffs in California. They are dedicated individuals, human beings, and musicians. "That's the only thing I will miss is my friends," he said.

"Music brings people to-

gether," said Molnar. There is a close relationship between the music and drama department. He finds harmony in this relationship—unlike other institutions that fight like "cats and dogs."

"We are here for the students and not for the glory," he said. He sees the primary role of the teacher as educator. "We are here for the education of young people and we are an example to them."



Along with these responsibilities goes a certain amount of power.

The ASB President must, within 25 days of a vacancy occurring, appoint a person

to fill that vacancy. The Senate, according to the Constitution and the By-Laws, does not have the power of approval or denial in these appointments. The President also has the power of veto, although it must be in written form, and the Senate must vote by 2/3 to override.

#### Succession to Office

In the event of the resignation or removal from office of the ASB President, the Legislative Vice-President will assume the office. The President Pro-Tempore of the Senate would then become Legislative VP and appoint from the ranks of the Senate a new Pro Tem.

Theoretically, it is possible to be appointed to the Senate and become President without having to stand for elec-


tion. In fact, this happened as recently as 1980, when then-Senator Tim Sheehan was appointed President Pro Tem, then succeeded to the Vice-Presidency and then, upon the forced resignation of President Jim Sowers, became President.

#### Removal

ASB officers can be removed from office, pre-sumably by action of the Constitutional Appeals Committee. The student body at large does not have the right of recall.

#### Election

An elections commissioner is appointed by the President and must be approved by 2/3 vote of the Senate. He or she oversees the election process and cannot hold any other position for the one-year term of office.
