### History, Politics, and the Fact

One of the top issues in this year's elections was campaign reform. Many ideas were presented to the incoming Congress, and one request stands out among the rest. Aside from limits on financial contributions, one of the items being considered is the implementation of a national petition process, allowing every eligible voter to cast a ballot on national issues. This possibility raises some serious concerns.

The main question here is, what use would there be for the current legislative branch of the federal government? Are the Congressmen (and women) not elected locally to represent their constituents in the nation's

capitol? The senators and representatives are chosen to be the people's voice, to cast the people's vote on national issues. If those represented do not agree with their decisions, the power of re-call does exist to unseat politicians that displease the voters in their district.

There is a reason that the government is set up the way that it is. The founding fathers drafted the constitution to insure individual's rights and liberties, while constructing the government to keep the balance of power equal with a system of checks and balances. Elitist in their thinking, they felt that common men were not capable of coming to highly important decisions on controversial subjects, as at that time only the wealthy were able to afford an education at a university.

The people, which were at that time free white men, were allowed to elect representatives whose judgment they trusted to be fair and sound. As ridiculous and outdated as this mode of thought is, it does lead to a disturbing question.

If the citizenry was allowed to vote on national issues, how would it be known

court system. They view our democracy as a debauchery, because in their eyes the government does what it wants while suppressing the citizens by giving them a false sense of power.

Actually this view is incorrect. Though to some, government may represent a public enemy, it actually plays the role of protector of the people. In 1994 Proposition 187 was overwhelmingly passed by California voters. This proposition proposed the immediate withdrawal of all benefits to illegal immigrants and threatened deportation. But to the chagrin of the voters, it was overturned in court.

Why? Contrary to popular belief, the majority of Californians receiving public assistance are citizens. Also most of these illegal immigrants are cheap labor and provide for the prosperity of one of the most productive agricultural regions in the world and deserve the benefits they receive.

If Proposition 187 found acceptance in the courts, agriculture would experience a cheap-labor shortage which would force more expensive labor to be hired, thus in return creating higher prices and disgruntled consumers. The courts not only protected

### Proposition 215

A wise man once said, "You can't legislate morality." You also can't force people to do the right thing. The problem with Prop 209 is there shouldn't have to be laws forcing people to hire minorities and women.

This proposition is worded to make a person feel they are voting against discrimination but to many, it seems to remove a law that bans

Being a victim of discrimination myself, I can honestly say I'm sorry this bill passed. As a young single mom of four in the seventies, I earned as

much as \$2.50 per hour less than my male counterparts although I did the heaviest and the hardest work. When I enquired of my employer why he simply stated, "Because you are a woman, my dear."

An employer couldn't do this these days because he would be libel for a lawsuit. Is it now back to the old standards of hiring, and lower pay for being "less qualified"?

Of course there is an argument for Prop 209, because some people were passed over for minorities who may not have been as qualified for certain jobs. By "qualified" it means, some have had better advantage for education, they are not a different color, they are not the "weaker" sex.

Some will say they worked hard for a position and it

Proposition 210, the minimum wage initiative, passed with nearly two-thirds of the voters' support. This initiative will increase the state minimum wage to \$5 per hour on Mar. 1, 1997 and will further increase to \$5.75 per hour on Mar. 1, 1998.

Opponents of Proposition 215 will not let their opposition to the medical use of marijuana die without a fight. They plan to go to court to block implementation of the newly passed initiative. They have also threatened to seek out a higher power—the federal government, to enforce laws that still outlaw marijuana as an illegal substance. Their arguments against this initiative that barely passed with 55% of the vote, center on the facts that it does not require a physician's written prescription, nor does it state any minimum age requirement for those who wish to use marijuana.

The facts are that this measure will allow the cultivation and use of marijuana

strictly for medicinal purposes, and only with a physician's approval. This measure will not allow recreational use of the drug or its sale. Many AIDS and cancer patients, as well as those afflicted with other serious illnesses, have been using prescribed cannabis for pain relief, and will now be able to do so without fear of prosecution. Tight controls that limit marijuana use to patients only will remain in place.

It's a shame that even though the people of this state voted, sending a clear message that more of us feel that it's okay for seriously ill people to use marijuana medicinally than those who do not, this measure may be overturned in court. It goes to show what a fallacy our concept of democracy is when a majority of us can reach a decision on an issue, controversial or not, and then have the displeased minority undo all of it in a court of law. It is not democratic,, and it is not right.

Last week's story by Sukhvir Singh Sodh, entitled "Library or Prison," has caused quite a commotion.

The article, alleging unfair treatment of minorities, and a stifling of a creative study atmosphere by library staff is "the latest tactic in an ongoing war between librarian Virginia Jolliff, and a certain group of students from India," one assistant librarian said.

"We were really surprised that the Rampage did that story without checking with us first. It was really unfactual." Jolliff said. "We've had problems for many semesters, it seems to be primarily with this group. When it's always the same group you remember."

Other librarians agree with Jolliff. "It's a group of six or seven students from India who have been going into the new wing of the library, kicking up their feet, gabbing and playing cards." Said librarian Ron Byrd. They have been kicked out of the library about three or four times; Dean of Students Robert Fox and the police have been contacted in the past because of the disturbance this group causes.

Byrd said that there have been several complaints from other students about the noise level when this group is present. He goes on to say that that the rules allow two people to talk quietly at a table, and if they wish to seat more to a table, there are accommodations around the corner of the room. If all else fails, there is the cafeteria which accommodates eight people per table and a substantially higher noise level.

"We're here to serve." Said David Racki, Reference Librarian. "We do so much for students, for them (the group of students) to blast us like that is just too much." The librarians hold that they make the rules, and the rules are expected to be followed.

are uneducated or ignorant of all of the various facets shaping today's issues. It is merely used to illustrate that many voters might vote impulsively on issues that demand close scrutiny and debate, something many citizens simply do not have the time to do with their work, school, or children taking up the bulk of their day. In theory, a national petition process where every single eligible voter actually casted a ballot would be wond-

erful. Unfortunately the reality is that voter apathy is already high, and those that do vote do not represent an equal sampling of our society. Traditionally, the old vote more than the young, the poor vote far less than those that are financially comfortable, white people vote in far greater numbers than all of the minorities combined, and those with strong religious beliefs take to the polls in force. Perhaps it is better

to keep the national law-making process as it is, with the elected representatives doing what they were elected to do and voting on the issues that come before them.

people. On the most part these elected officials are highly educated, specifically in law and economics, and are quite knowledgeable with the issues, whereas the majority of the people are not. They are paid to be meticulous in analyzing, scrutinizing, and debating the issues concerning a public that is apathetic, undereducated, and assiduous with other affairs. They make the decisions in the best interests of the people instead of letting them haphazardly vote in a direct democracy. Another problem with direct democracy is it is not completely representative because only a minority vote. Even though an indirect democracy too is the result of a minority vote, the elected officials from it represent both voters and non-voters— a broader representation. Through this process the majority are protected form the inhibitions of the minority, and both are protected from their collective ignorance.

With the use of representative assembly and the court system, our government is effectively protecting its people from their worst enemy— themselves. Because the majority of Americans lack the knowledge required to make adjudications concerning paramount topics, it is to their benefit having representatives decide most of the issues for them, and the judicial branch to check these definitives. This is why Proposition 215 should have been a legislative matter, and it is essential that its fate is to be determined in court. Remember: Big Brother is watching you, but he's not such a bad guy after all.
